2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the 195 patients with PHT who underwent elective TIPS. The topic is within the scope of the WJG. (1) Classification: Grade B, Grade A and Grade B; (2) Summary of the Peer-Review Report: This study is desgined well. The methods are described in adequate detail. The results are interesting. However, the manuscript still needs to be edited. Tables and languages need</p>	[Y]

to be modified. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 1 figure. A total of 36 references are cited, including 14 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has published 3 articles in the BPG. This Title is similar to No. 58242 (Rejected). 5 Issues raised: (1) I found the title was more than 18 words. The title should be no more than 18 words; (2) I found no "Core tip" section. Please provide the core tip; (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) please don't include any *, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters. Statistical significance is expressed as aP < 0.05, bP < 0.01 (P > 0.05 usually

If there are other series of P values, cP < 0.05 and dP < 0.01 are used, and a third series of P values is expressed as eP < 0.05 and fP < 0.01; and (5) Please write the "Conclusion" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
