(1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: Pancreatic cancer is one of the common malignant tumors in digestive system, which has the</p>	[Y]

characteristics of late detection, early metastasis, rapid progress and poor prognosis. This study is overall very interesting, and the research objectives are achieved by the experiments used in this study; and (3) Format: There are 2 tables and 2 figures. A total of 23 references are cited, including 15 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: Please provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form and Written Informed Consent. No academic misconduct was found in the CrossCheck detection and Bing search. The highest single-source similarity index in the CrossCheck report showed to be 14%. The CrossCheck results showed the similarity to be high. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. Without financial support. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can

	<p>be reprocessed by the editor; (2) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; (3) the author should number the references in Arabic numerals according to the citation order in the text.
