is 1 self-citation. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJH. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I have changed the manuscript type from "Review" to "Minireview"; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) the in-text citations numbers should be positioned within square brackets and be superscripted; (5) please provide an audio core tip file where the core tip content is recorded; and (6) please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
