There is 1 self-citation. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the CARE Checklist-2016. The authors need to please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the written informed consent where the patient(s) signed to agree to the treatment. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) please write the "Core Tip" section, and provide an audio core tip file where the core tip content is recorded; (5) please write the abstract section according to specific journal requirements; (6) please restructure the main texts of the manuscript to include subheadings of "INTRODUCTION", "CASE PRESENTATION" "FINAL DIAGNOSIS", "TREATMENT", and

“OUTCOME AND FOLLOW-UP”, according to the Guidelines and Requirements for Manuscript Revision; (7) the title should include “Three case reports”; (8) the in-text citation numbers need to be superscripted in square brackets at the end of the sentence with the citation content or after the cited author’s name, with no spaces; (9) please write the “Conclusion” section at the end of the main text; and (10) please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the written informed consent where the patient(s) signed to agree to the treatment. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
