informative about the CAPSI procedure and the risks of cement embolism. However, there are some issues should be addressed. First, it lacks adequate detail concerning the non-orthopedic portions. The treatment section needs further detail on the treatment of the embolism. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 3 figures. A total of 33 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by LetPub was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Fundamental Research Funds for the Central Universities. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not add the PMID and DOI in the reference list.
