Some typos and acronyms should be corrected thorough the text. Please add a</p>	[Y]

sentence in the abstract about iPSC. Moreover, the authors overview the use of iPSC technology to understand and treatment of IR and explain the challenges and limitations of using the human iPSC-based model. The questions raised by the reviewers should be answered; and (3) Format: There are 3 figures. A total of 89 references are cited, including 10 references published in the last 3 years. There are 5 self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade B. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Qatar National Research Fund. The topic has not previously been published in the WJSC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) There are 5 self-citations. The manuscript could only have 3 self-citations according to the editorial policy of BPG. Please check and revise. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
