The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors of this review article have tried to discuss the current pandemic situations and their relations with gastroenterology. possesses an important value. The review article is beautifully designed as a design and idea. However, there are different minor comments including the need for an English Language remake on the whole manuscript where there are many writing mistakes. The questions raised by the reviewer should be answered; and (3) Format: There are 2 tables and 1 figure. A total of 125 references are cited, including 105 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: (1) The “Author Contributions” section is missing. Please provide the author contributions; and (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor;. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
