The topic is within the scope of the WJGE. (1) Classification: Grade C and Grade D; (2) Summary of the Peer-Review Report: The authors presented a large retrospective cohort of patients who underwent urgent endoscopy</p>	[Y]

for either foreign body ingestion of food bolus impaction. In particular, they looked at the rates of adverse events under different sedation conditions. The patient cohort is very large and the data have been analyzed satisfactorily. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables. A total of 35 references are cited, including 7 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. The authors are native English speakers. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJGE. 5 Issues raised: (1) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
