2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor: 1</b> Scientific quality: The manuscript describes a case report of the double common bile duct manifesting as recurrent pyogenic cholangitis. The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: In this work, an extremely rare case of double common bile duct manifesting as recurrent pyogenic cholangitis was reported. However, there are several problems with the manuscript that need to be resolved. The interpretation of the picture, grammatical errors</p>	[Y]

and abbreviations need to be corrected. The questions raised by the reviewers should be answered; and (3) Format: There are 4 figures. A total of 12 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016 and Written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) Please write the "Conclusion" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
