The topic is within the scope of the WJGS. (1) Classification: Grade B and two Grades C; (2) Summary of the Peer-Review Report: The manuscript is well written and meets most criteria on the check list. The</p>	[Y]

questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 1 figure. A total of 47 references are cited, including 12 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Two Grades A and Grade B. A language editing certificate issued by a native English speaker was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJGS. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Recommendation: Conditional acceptance.
