The topic is within the scope of the WJGO. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This is an interesting paper that reported the case of a 59-year-old old man diagnosed with sigmoid adenocarcinoma who developed serial metastases in the lung and pancreas. written. The authors should do a further discussion in the conclusion paragraph on the lesson learned from this case and its utility for clinicians. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 3 figures. A total of 15 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Youth Program of National Natural Science Foundation of China; and the Medical Research Projects of Jiangsu Province. The topic has not previously been published in the WJGO. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
