(1) Classification: Two Grades B and Grade C; (2) Summary of the Peer-Review Report: Authors conducted an international survey on risk perceptions of contracting COVID-19 in patients with CeD. The topic is new and very interesting, well-written and well-discussed. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 1 figure. A total of 37 references are cited, including 18 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Two Grades A and Grade B. Authors are native English speakers. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Division of Gastroenterology AFP grant, Farncombe Family Digestive Health Research Institute Award etc. The topic has not previously been published in the WJG. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and
