2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a review of the chronic intestinal failure and short bowel syndrome in Crohn's disease. The topic is within the scope of the WJG, however, I suggest to transferring WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The title talks about CIF and SBS, but SBS is only one of the causes of CIF. This statement needs to be discussed better. It is necessary to discuss, among the causes</p>	[Y]

of CIF, both those from impaired digestive capacity and those from impaired absorptive capacity. CIF measurement systems, as well as clinical and laboratory parameters needed to diagnose CIF, must be explained and discussed; and (3) Format: There are 7 tables and 2 figures. A total of 160 references are cited, including 24 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Akdeniz University Research Foundation. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The reference's number cited in the text should be superscript.. 6 Re-Review: Required. 7 Recommendation: Suggest to transferring to WJCC.
