There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by Medjaden Inc was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and Written informed consent. The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 2 grants. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation.
