The topic is within the scope of the WJD. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors describe a potential role of VEGF-B signaling in promoting insulin resistance</p>	[Y]

through suppression of the PI3K/AKT pathway in a paracrine way. The results are quite interesting and clearly presented. However, a few recommendations might be considered. The questions raised by the reviewer should be answered; and (3) Format: There are 4 tables and 4 figures. A total of 59 references are cited, including 10 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate. The authors need to provide The ARRIVE Guidelines with page number, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The Institutional Review Board Approval Form is not needed. The Institutional Animal Care and Use Committee Approval Form or Document should be the Chinese format. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 4 grants. The topic has not previously been published in the WJD. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (4) The "Article
