The topic is within the scope of the WJG. (1) Classification: Two Grades B; (2) Summary of the Peer-Review Report: the authors tried to update the understanding of outcomes</p>	[Y]

for patients with ARM and analyze management trends around the world. The performed a multi-institutional, retrospective study of patients treated for ARM and a literature review to assess trends in surgical management and outcomes. They conclude that there is wide variation in the management of ARM and survival outcomes remain poor regardless of approach and surgical management should aim to minimize morbidity. The topic of this work is interesting. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 2 figures. A total of 49 references are cited, including 7 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. The authors are native English speakers. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text. 6 Recommendation: Conditional
