The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 1 figure. A total of 30 references are cited, including 14 references published in the last 3 years. There are 2 self-citations, which are related to the article. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and PRISMA 2009 Checklist. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJO. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) The reference cited in the text should be superscript; and (4) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
