The topic is within the scope of the WJGS. (1) Classification: Grade D and Grade C; (2) Summary of the Peer-Review Report: Diverticulitis is one of the most common diseases in gastroenterology. Surprisingly, the data on its occurrence as a complication after an endoscopy are lacking. It is reasonable that the new data on this topic appears. The issue is clinically significant; the researchers' approach is innovative</p>	[Y]
