Abstract is inconsistent with that in Text; the ethical statement should be added; all estimates should report a 95% confidence interval; how to calculate appropriate sample size; if the authors can do propensity score matching analysis, the article will be more convincing; and (3) Format: There is 1 table and 2 figures. A total of 45 references are cited, including 9 references published in the last 3 years. There are 4 self-citations. 2 Language evaluation: Classification: Grade B. The authors are native English speakers. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJO. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (5) Authors
