	<p>serum, and HBsAg seroconversion throughout the treatment period, which sustained for more than three years after discontinued antiviral therapy. It is a rare and interesting case report, the manuscript was well written. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 1 figure. A total of 19 references are cited, including 5 references published in the last 3 years. There are no self-citations.</p> <p>2 Language evaluation: Classification: Grade B. A language editing certificate issued by Filipodia was provided. 3 Academic norms and rules: The authors provided the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents.
