Eastern diet is very different from the Western diet and food that might trigger IBS symptoms should be identified in these regions. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 2 figures. A total of 64 references are cited, including 27 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Key Technology Support Program during “12th Five-Year Plan” period of China, the Leap-forward Development Program for Beijing Biopharmaceutical Industry. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents.
