The topic is within the scope of the WJGO. (1) Classification: Grade B; (2) Summary of the Peer-Review Report:</p>	[Y]

This manuscript mainly compared the efficacy and safety profiles of AFL in the second-line and salvage therapy settings of colorectal cancer patients. This research has certain clinical guiding significance, however, it still have some deficiencies which need to be revision. The questions raised by the reviewer should be answered; and (3) Format: There are 3 tables and 1 figure. A total of 18 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Filipodia was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and the Institutional Review Board Approval Form. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and STROBE Statement with the page number. Written informed consent was waived. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJGO. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
