the ctDNA results confirmed the treatment in this study. The quality and importance of this manuscript is quite good. The conclusions do appropriately summarize the data that this study provided and they offer a useful reference for retreatment with osimertinib. However, some misspellings throughout the manuscript and the wrong unit should be corrected. The questions raised by the reviewers should be answered; and (3) Format: There are 3 figures. A total of 13 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors provided the written informed consent. The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the CARE Checklist-2016 with page number. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 2 grants. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures.
