2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of the anesthetic management of a child from the Qinghai Tibet Plateau with a double outlet right ventricle and severe polycythemia. The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors reported an interesting case of double outlet right ventricle paired with severe erythrocytosis. The patient's</p>	[Y]

characteristics, anesthetic management, and the in-patient follow-up were described adequately. This article can be a useful guide for other practitioners that could face similar challenging conditions. The manuscript title is clear and representative. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 4 figures. A total of 14 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Edanz was provided. 3 Academic norms and rules: The authors provided the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China, Research Grant from the 1.3.5. project for disciplines of excellence, West China Hospital, Sichuan University. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s).
