	<p>is well written, but the content is sort of concise, outmoded, as a full-length article. Maybe it will be more well in the type of LETTER; and (3) Format: There are 2 tables and 3 figures. A total of 42 references are cited, including 17 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and PRISMA 2009 Checklist. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.</p> <p>Editorial Office Director:</p> <p>Manuscript_FirstCommentByEditorialOfficeDirector</p> <p>Company Editor-in-Chief: The title of the manuscript is too long and must be shortened to meet the requirement of the journal (Title: The title should be no more than 18 words).
