(1) Classification: Grade B; (2) Summary of the Peer-Review Report: This well written review can provide comprehensive understanding about fecal incontinence (FI), which is often under-reported. Therefore, familiarity of this entity can facilitate clinicians to think of the possibility in some patients. MR defecography can reveal some abnormalities in some</p>	[Y]

patients and these findings can impact the surgery pattern choosing. However, MR defecography findings should be included in this review; and (3) Format: There is 1 table and 5 figures. A total of 41 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) The column should be the minireviews. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
