There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade C. A language editing certificate issued by MedEditing LLC was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and Written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 2 grants. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The language classification is Grade C.
