There is 1 self-citation (Ref. 15). The topic of the self-citations is related to this study. 2 Language evaluation: Classification: Three Grades B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Beijing Municipal Education Commission Science and Technology Plan General Project. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s).
