involvement of corona viruses infections. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 1 figure. A total of 122 references are cited, including 72 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Recommendation: Conditional acceptance.
