The topic is within the scope of the WJCC. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: The authors reported an interesting case report about simple technique of biliary reconstruction in</p>	[Y]

liver transplant setting. The outcome of cholangiojejunostomy was quite good in short-term follow up. However, some questions raised by the reviewers should be answered; and (3) Format: There are 2 figures. A total of 13 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and Written informed consent. The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The reference's number cited in text should be superscript. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
