(1) Classification: Grade B, Grade B and Grade C; (2) Summary of the Peer-Review Report: The manuscript reported a well-written manuscript with important findings. However, the discussion should be replenished. The questions raised by the reviewers should be answered; and (3) Format: There are 7 tables and 3 figures. A total of 53 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade A and Grade B. A language editing certificate issued by American Manuscript Editors was provided. 3 Academic norms and rules: The authors provided the Institutional Review Board Approval Form. The authors need to provide the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and STROBE Statement with page number. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6
