The topic is within the scope of the WJG. (1) Classification: Two Grades B; (2) Summary of the Peer-Review Report: The topic is really interesting and still much debated in literature. The manuscript is well written. The introduction is well structured. The discussion is complete and exhaustive. The questions raised by the reviewers should be answered; and (3)</p>	[Y]

Format: There are 3 figures. A total of 26 references are cited, including 12 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Two Grades B. The authors are native English speakers. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID numbers are missing in the reference list. Please provide the PubMed numbers to the reference list and list all authors of the references. Please revise throughout; (4) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Recommendation: Conditional acceptance.

Company Editor-in-Chief: As a meta-analysis article, the manuscript was not written based on the author's own work, precluding its ability to meet the requirements of an invited manuscript for the World Journal of Gastroenterology. Thus, I
