the Peer-Review Report: In this article, the authors well describe the impact of glycemic fluctuations during dumping symptoms using continuous glucose monitoring, and give a more detailed glycemic profile during early and late dumping, also comparing the reconstruction methods after gastrectomy, adding new evidence on the onset of dumping syndrome.; and (3) Format: There are 2 tables and 2 figures. A total of 29 references are cited, including 7 references published in the last 3 years. There are 2 self-citations (Ref. 4, 9). The topic of the self-citations is related to this study. 2 Language evaluation: Classification: Grade B. No language editing certificate was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (3) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to this study. 6
