given that CCA is a deadly cancer with limited therapeutic option due to a late diagnosis. Early phases of CCA carcinogenesis are usually asymptomatic and biomarkers for CCA diagnosis lack specificity and sensitivity. Thus the identification of cancer susceptibility markers is clinically relevant in CCA. However, some questions raised by the reviewers should be answered; and (3) Format: There is 1 table. A total of 32 references are cited, including 16 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The STROBE Statement need to the page number. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 1 grant. The topic has not previously been published in the WJGO. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; and (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s). 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
