The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report:</p>	[Y]

This is an interesting very well written comprehensive review on HEV infection in organ transplant patients. All sections are well written and explained. The limitation section is very good and it opens ideas for future researches in the field; and (3) Format: There are 2 tables and 3 figures. A total of 33 references are cited, including 9 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the PRISMA 2009 Checklist. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. The corresponding author has 5 published articles in the BPG. 5 Issues raised: I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
