In this paper, the authors reported an interesting and comprehensive review on early diagnosis of HCC; and (3) Format: There are 2 tables and 2 figures. A total of 119 references are cited, including 104 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 3 grants.
