of the WJEM. (1) Classification: Two Grades B a; (2) Summary of the Peer-Review Report: This study presents a new multiple route administration of MSC for HIE. The results in term of safety are good as well preliminary efficacy but with a short population. The questions raised by the reviewers should be answered; and (3) Format: There are 9 tables and 3 figures. A total of 25 references are cited, including 11 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by Protranslate was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJEM. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Recommendation: Conditional acceptance.
