2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor: 1 Scientific quality:</b> The manuscript describes a basic study of the Mitochondrial pathway of the lysine demethylase 5C inhibitor, CPI-455, on the Eca-109 esophageal squamous cell carcinoma cell line. The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The results showed that CPI-455 inhibits ECA-109 cell proliferation via mitochondrial apoptosis pathway by regulating the expression</p>	[Y]

of related genes. The manuscript is very interesting. The study confirmed the anti-tumor effect of CPI-455 in esophageal squamous cell carcinoma and provide a theoretical basis for the application of CPI-455 for the treatment of esophageal squamous cell carcinoma. The manuscript is well written. The questions raised by the reviewers should be answered; and (3) Format: There are 6 figures. A total of 22 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by ELIXIGEN was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Health Research Fund of Hubei Province, Top Medical Youth Talent Program of Hubei Province. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) The "Article Highlights" section is missing.
