The topic is within the scope of the WJCO. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The topic of the manuscript is interesting and attractive. Oncological treatment protocols must adapt to this new health threat for patient and medical staff to minimize morbidity</p>	[Y]

and maximize survival. However, some questions raised by the reviewers should be answered; and (3) Format: There are 2 tables. A total of 19 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJCO. 5 Issues raised: (1) The authors' information should be added in the first page; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The reference's number cited in the text should be superscript. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
