The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: this manuscript makes concrete contributions to the knowledge on a rare disease sclerosing polycystic adenosis of the submandibular gland". Previous scholars mainly focused on this disease arising from the</p>	[Y]

parotid gland, while the authors summarized the characteristics of sclerosing polycystic adenosis cases of the submandibular gland, a rarer entity, and presented two new cases. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 2 figures. A total of 20 references are cited, including 4 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade B. A language editing certificate issued by MogoEdit was provided. 3 Academic norms and rules: The authors provided the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents.
