(1) Classification: Grade C; (2) Summary of the This case report describes a case of Acquired hepatocerebral degeneration in a metastatic small intestine NET long-term survivor. The questions raised by the reviewers should be answered; and (3) Format: There are 5 figures. A total of 23 references are cited, including 5 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B. No language editing certificate was provided. 3 Academic norms and rules: The authors provided the written informed consent. However, the informed consent of treatment is not provided. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJH. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Recommendation: Conditional acceptance.
