descriptive with pertinent clinical and test result information to the reader. However, the questions raised by the reviewer should be answered; and (3) Format: There is 1 table and 5 figures. A total of 27 references are cited, including 3 references published in the last 3 years. There are 3 self-citations, which are related to this article. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by MedSci was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016 and written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 1 grant. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation. Please re-write the "Case Presentation" section, and add the "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" sections to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Not required. 7 Recommendation: Conditional
