The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 3 figures. A total of 24 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. No language editing certificate was provided. 3 Academic norms and rules: The written informed consent of treatment is not provided; the authors submitted a wrong document. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript (The invited title was submitted and accepted as clinical trial study, but this study is a case report). No financial support was obtained for the study. The topic has not previously been published in the WJO. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to this study; and (3) Please provide the written informed consent of treatment. 6 Recommendation: Conditional acceptance.
