The topic is within the scope of the WJO.(1) Classification: Grade C(2) Summary of the Peer-Review Report: In this case report and review of literature, the authors describe a rare Salmonella infection following ACLR and highlight the importance of early diagnosis and management. It's useful for prevention and treatment of infectious septic arthritis. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 3 figures. A total of 24 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. No language editing certificate was provided. 3 Academic norms and rules: The written informed consent of treatment is not provided; the authors submitted a wrong document. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript (The invited title was submitted and accepted as clinical trial study, but this study is a case report). No financial support was obtained for the study.
