The topic is within the scope of the WJH. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: The authors present their study about the effect of age on clinical outcomes in patients with cholangitis. The</p>	[Y]

authors are to be commended on conducting this study on this large number of patients. The methods of the study seem appropriate and conclusions valid, however there are some issues should be addressed. The authors limited the inclusion criteria to choledocholithiasis. This needs clarification and clearly impacts the generalizability of the results. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 2 figures. A total of 48 references are cited, including 12 references published in the last 3 years. There are 11 self-citations. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJH. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; and (4) There are 11 self-citations. The manuscript could only
