Science Editor: 1 Scientific quality: The manuscript describes a Case Control Study of the fibroblast growth factor 21 in alcohol-induced liver cirrhosis. The topic is within the scope of the WJH. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: Overall a good study with a few issues. Some points need to be clarified. The questions raised by the reviewers should be answered; (3) Format: There are 4 tables and 1 figure; (4) References: A total of 37 references are cited, including 14 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference. 2 Language evaluation: Classification: Grade A. The manuscript is reviewed by a native English speaker. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, the Written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Medical University of Lublin. The topic has not previously been published in the WJH. (13) 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide
