The topic is within the scope of the WJG. (1) Classification: Grade D, Grade C, Grade B and Grade C; (2) Summary of the Peer-Review Report: This is a review about immunotherapy for pancreatic cancer. The description of the article is systematic and comprehensive. It is a topic of interest to the researchers in this area. However, the safety and efficacy of these drugs are not analyzed in detail. effects of immunotherapeutic agents should not be underestimated, which should be recognized and managed properly in daily clinical practice. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 1 figure. A total of 67 references are cited, including 24 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B, Grade A and Grade B. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search.

4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: (1) The column should be minireviews; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) Please obtain permission for the use of picture(s). If an author of a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for the figure to be re-published; and correctly indicating the reference source and copyrights.
