positive CHB with HBeAg loss. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 4 figures. A total of 23 references are cited, including 11 references published in the last 3 years. There are 5 self-citations (Ref. 5, 13, 14, 15, 22). The topic of the self-citations is related to this study. 2 Language evaluation: Classification: Three Grades B. A language editing certificate issued by Rhine Language Editing was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Shandong Province Natural Science Foundation, National Key Research and Development Program of China. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) The "Article Highlights" section is missing.
