reviewers should be answered; and (3) Format: There are no tables and figures. A total of 97 references are cited, including 53 references published in the last 3 years. There are 11 self-citations (Ref. 3, 4, 19, 33, 44, 53, 54, 63, 64, 65, 66). The topic of the self-citations is related to this study. 2 Language evaluation: Classification: Grade A. The authors are native English speakers. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJP. 5 Issues raised: (1) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (2) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to this study. Authors should cite no more than 3 their own published articles. Please check and remove the inessential self-citations; and (3) Please add table/figure to the manuscript. 6 Recommendation: Conditional acceptance.
