increasing worldwide burden of IBD. The questions raised by the reviewers should be answered; and (3) Format: There is 1 tables and 5 figures. A total of 47 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by eWorldEditing was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Animal Care and Use Committee Approval Form. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Research Foundation of Korea. The topic has not previously been published in the WJG. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (5) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and
